Hi Johanna/John,

We had Judy Murray and her team in yesterday to meet with Kevin Roberston, Bob Gil and myself to take forward her plans for Park of Keir. Progress has been made by them, particularly in relation to capital costs and the need for a contribution from executive housing to cross fund the sports elements. There is still some way to go, however.

We discussed timescales for public consultation pre-planning submission and also the potential to link this to our bid for NPCCS. Discussion came down to June as the period for pre-planning consultation on Judy's scheme. This ties in very well with the NPCCS bid which, as you know, has to be submitted by 5th July. However, we are not disregarding the potential for a public reaction to two developments on sensitive and prominent sites around Bridge of Allan! It will need very careful handling.

We have agreed that the next step is to arrange a discussion with Colin Liddell who I have asked to help us with communications on NPCCS

I envisage a broad meeting of all interested parties, including Active Stirling, to map out a communications strategy that we can then take into partnership discussions with the University. If we can get a momentum going of a series of key announcements through June strengthening Stirling's bid - Cricket, Curling, Judy Murray - this would be a good run in to the bid submission. We set the whole this in the context of Stirling becoming Scotland's City of Sport as these sports it to join us.

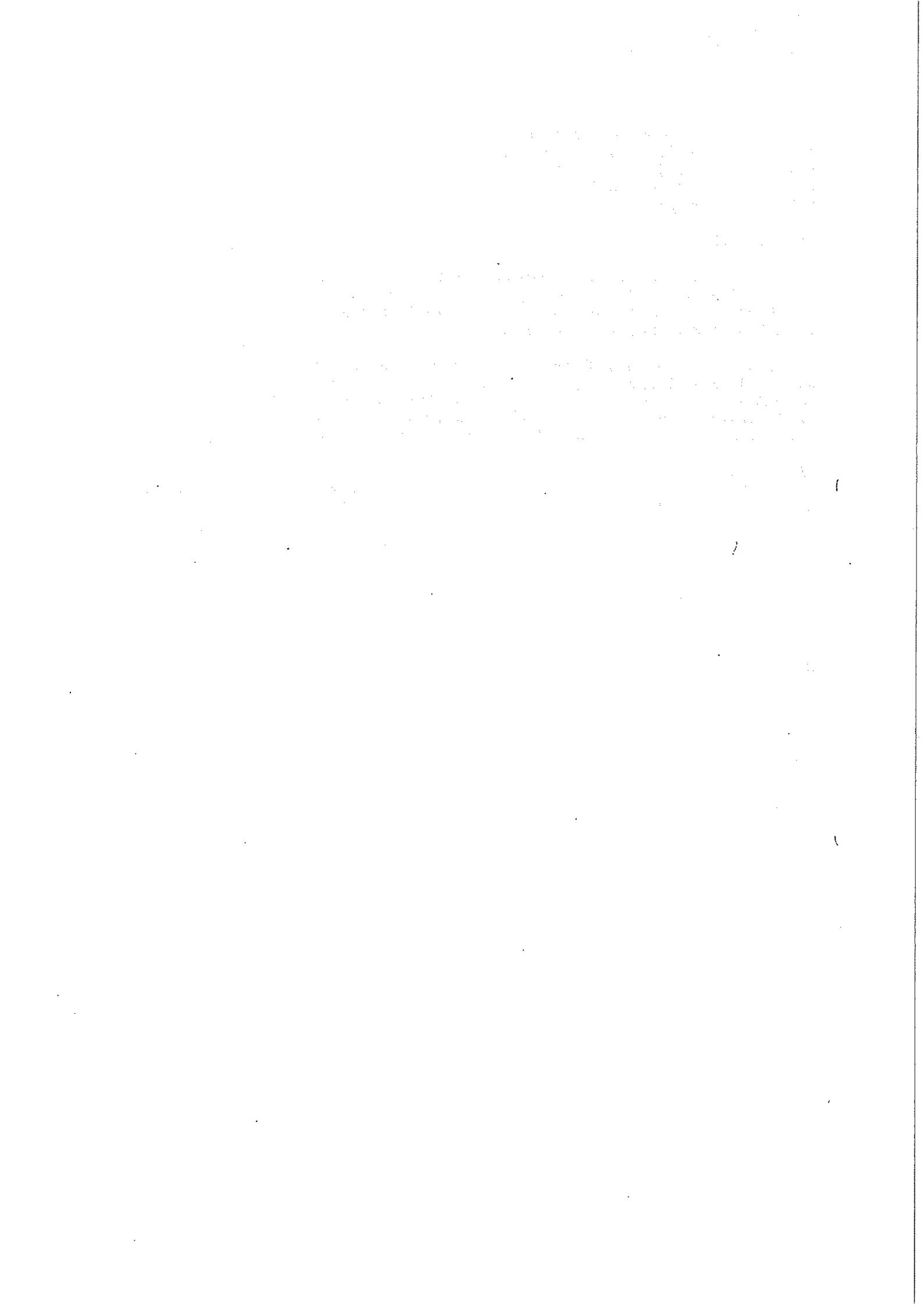

Morning Alston,

Thanks for your e-mail and for our very useful meeting last week.

I will get back to you just as soon as possible with a date for a meeting with Colin Liddell.

We are, of course, mindful of your intention to commence pre-planning consultation during June. As discussed, this ties in very well with the next stage of the bid process for the National Performance Centre for Sport, as we have to submit the Stage 2 bid by 5th July. We will be working up a communications plan for Stirling's bid for the NPCS and anticipate a series of announcements through May to July.

If we can link Judy's project to this, in the sense of adding to Stirling as Scotland's City of Sport and the Bridge of Allan/Stirling University/Wallace High School/Forthbank Sports Village as the Stirling Corridor of Sport, this greatly strengthens both projects in our view. We are also hopeful of announcements on cricket and curling joining with the Stirling NPCS bid in this period.

**Tennis Academy**

we agreed to keep in touch regarding your plans for the Tennis Academy.

I was disappointed when you told me that you were looking outside Stirling to other areas and then to read the following week about the possibility of something happening at Cramond. I now see from this morning's Herald that Stirling may be back in the reckoning and I therefore wanted to write to you immediately to reaffirm our commitment to working with you to achieve this ambition.

I believe there is no better location in Scotland than Stirling in terms of accessibility to all other areas. There are several excellent sites (some of which we have previously explored) that are either under the control of the Council or over which we can exert some influence.

There are many exciting developments in the pipeline that will greatly raise the profile of Stirling in the next few years. To mention just one very relevant project, we are collaborating with the University and Active Stirling to put together a bid for the National Performance Centre for Sport to be located in Stirling. A clear link between this and your plans for the Tennis Academy could clearly strengthen and benefit both projects, not least in terms of available capital funding.

I would welcome an early opportunity to meet with you and your team to discuss where we could take our respective plans.
